The Presidential Management Fellows (PMF) Program is the Federal Government's premier leadership development program for advanced degree holders across all academic disciplines

PMF Program Mission: To recruit and develop tomorrow's Federal Government leaders



PMF Program Overview


- Pipeline for Future Leaders in Federal Government
- Involves a very competitive and rigorous on-line application and assessment process
- Solicits eligible individuals annually (Applicants)
- Selection of Finalists
- Finalists seek appointments as Fellows
- Two-year fellowship of training and development, with potential to be converted to a permanent position
- Initial appointment at the GS-9, 11, or 12 (or equivalent)
- Promotion potential to the GS-13
- Succession Planning for Federal Agencies

The Fellowship Includes

- Onboarding with your fellowship class
- Rigorous Leadership Development & Individual Development Plan
- 160 hours of formal interactive training
- At least one 4-6 month Developmental Assignment
- Optional Rotational Opportunities
- Assignment of senior-level Mentor
- Potential Appointment Benefits such as Public Transportation Subsidies, Telework, Student Loan Repayment
- Opportunity to non-competitively convert to a term or permanent Federal position upon successful completion of program requirements

Confirm Eligibility

Confirm your eligibility (including degree date, citizenship, veterans' preference, Indian preference, education outside of the U.S., and attorneys) by reviewing the "Become a PMF\Eligibility" webpage at

Assemble Documents

All Applicants must submit a resume and an advanced degree transcript, along with supporting documentation if claiming Indian/Veterans' Preference or requesting a reasonable accommodation. Find more information at https://www.pmf.gov/beco me-a-pmf/applicationprocess/application-tips/

Create an Applicant User Account

Start Application

When the annual PMF application launches, it will be advertised as an announcement at www.USAJOBS.gov and referenced on the PMF website at www.pmf.gov. information, and document Read the announcement and the "Become a PMF" webpage thoroughly!



Assessment

Certify and Submit Application

Applicants may only certify and submit one application. Applicants will be asked to certify they completed the application, including the online assessment. independently and without assistance. Applicants can monitor their application status via their applicant user account.

Adjudication

Shortly after the application closes, all Applicants will be adjudicated on eligibility, complete application, assessment scores, and other factors leading to the selection of Finalists. The time from the application closing to the announcement of Finalists can take 4-6 weeks.

Announcement of Finalists

When Finalists are selected, all Applicants will be informed of their status and a list of Finalists posted to the PMF website at https://apply.pmf.gov/finalis ts.aspx and Finalists should visit https://www.pmf.gov/beco

Find an Appointment

From the date of selection. Finalists have 12 months to secure a PMF appointment. Finalists can search for appointment opportunities on-line. Once a Finalist accepts a PMF appointment offer and it is recorded their status changes to Fellow!



Application Process & What to Expect

- Application typically takes place annually in the fall (Sep/Oct)
- Announcement is posted on www.USAJOBS.gov; applicants apply on PMF Talent Management System (TMS)
- Applicants submit an on-line application which includes:
 - Resume
 - Advanced Degree Transcript (and/or alternative)
 - Supporting documentation for any claims to Indian preference, veterans' preference, and/or reasonable accommodations
 - An On-Line Assessment
- Finalists are typically announced six weeks after application closes (Nov)
- As a Finalist you have 12 months of appointment eligibility
- Upon securing position with a participating Federal agency → Fellow



2021 On-Line Assessment

- The on-line assessment is designed to identify evidence of the following competencies that are critical to success on the job across all PMF occupations:
 - Flexibility
 - Integrity
 - Interpersonal Skills

- Public Service Motivation
- Problem Solving
- Written Communication
- The on-line assessment consists of four batteries covering the following:
 - Situational Judgment
 - Problem Solving

- Life Experience
- Writing
- Assessment Preparation Guide posted to the PMF website in the late Spring/early Summer



Who can apply? How to Apply?

Who Can Apply:

- Graduate Students world-wide
- Advanced Degree from an accredited institution
- Must have advanced degree requirements completed by Aug 31st following the application year
- May apply within the last year of study <u>OR</u> up to 2 years after completing advanced degree
- Either a U.S. Citizen OR have the ability to legally be able to work in the U.S.

How to Apply:

- Review the "Become a PMF" section on the PMF website (<u>www.pmf.gov</u>) for the next annual application
- Follow instructions and link found in announcement posted at <u>www.USAJOBS.gov</u> when the application opens



Application: Top 3 Common Mistakes

1) Transcript issues

2) Insufficient documentation

3) Waiting until the last minute

Many applicants submit transcripts that are missing required elements such as name, school name, degree program and type, and most importantly, the date the degree was conferred or is expected to be completed. To make sure your transcript has everything it needs, go here: https://www.pmf.gov/become-a-pmf/application-process/application-tips/.

Some applicants are missing alternative documents associated to a transcript when a required element is missing (e.g. degree date completion), documents related to Veterans' Preference and/or Indian Preference, or documents related to a request for a reasonable accommodation for the on-line assessment.



Many applicants do not start the application process until the night before or even hours before it closes. The entire application and on-line assessment can take 3-4 hour to complete. All of this takes time. Do yourself a favor and don't wait until the last minute!
